In the name of God amen. I **Hannah Rudd** of Chesterfield County being in good health of Body and in perfect sense and memory praise be God for the same do make & establish & ordain this my last will and Testament in manner & form following. And first I recommend & give my Soul into the hands of almighty God who gave it me hoping through the meretorious Death and passion of my blessed Lord & Saviour Jesus Christ to receive pardon and forgiveness for all my Sins and a joyfull resurrection on the last day. My Body I give to the Earth to be buried in a decent and Christian like manner at the discretion of my Executors hereafter named. And for what worldly Estate it hath pleased almighty God to bestow upon me I give bequeath & dispose of in manner & form following Viz

Item I give unto my son **John Rudd** the sum of five shillings Sterling to be his full part of my Estate to him and his heirs forever.

Item I give unto my daughter **Avis Whittecar Cashing** the sum of five shillings Sterling to be her full part of my Estate to her & her heirs forever.

Item I give unto my daughter **Hannah Cheatham** the sum of five shillings Sterling to be her full part of my Estate to her & her heirs forever.

Item I give unto my grandson **Rusell Kennon** one feather bed bedstead & Furniture one Iron Pott one puitter dish of a meddle size and three puter plates to him and his heirs for ever.

Item I give unto my granson **Thomas Palmer** one feather Bed bedsted & Furniture, one Iron pott, one peuter Dish & three peuter plates to him & his Heirs for Ever

Item I give unto my Nephew **Edward Storey** one feather Bed bedsted and furniture one Iron Pott of a middle size one chest which was his Fathers one M_____ and (six pence ??) in Cash to him & his Heirs for Ever.

Item my will & desire is that after my funeral expences all my just debts & Legacies are paid that all the rest of my Estate Household Goods, Stooles of all kinds Money Crop or Debts due to me and all my wearing apparel be equally divided between my two daughters **Jane Kennon** and **Ann Palmer** to them & the heirs of their Bodies forever. And lastly I nominate & appoint my sons in law **Simcock Kennon** & **Ellis Palmer** to be my Executors and I hereby disanul & make Void all former wills heretofore by me made & do acknoledge this to be my last will and Testaments. In Witness where of I have hereunto set my hand & fixed my Seal this 2nd day of October in the year of our Lord Christ 1771 years
