John Rudd/Rudds/Ruddes, but there are no records of this man owning property in Virginia or having any relatives who lived there named Rudd. Ask anyone claiming there was an ancestor named Capt. John Rudd for proof of the land ownership or any record of relationship or evidence of origin in Yorkshire, and you will find there is no documentation.

If John Rudd, Sr., is the John Rudd of Liverpool, his period of indentured servitude was 4 years; therefore, he and Avis could have married by 1705 or1706. If, however, Avis's period of servitude was the usual 7 years, they would have had to wait until about 1708/1709. Indentured servants were not allowed to marry.

John REED and Wife Avis REED appeared before the Henrico Co. court to claim headrights due under the importation system. NOTE: This shows that John Rudd & Avis Whiteker were married by 1709. Mary Gregg's

notes: "We know from the will abstract, that John Rudd (father of the above Thomas and William) had willed to William a slave and 1/2 of the 'land I live on.' He had stipulated that 'If William Rud never returns here' then the slave and land were to go to his grandson, William, son of Joseph Rud." Mary points out the above deed indicates that William did hear his father had died and he should contact Thomas. She concludes that Thomas must have been an adult by 1749 and William must have been at least 15 when he left home. He had been gone for about 16 years in 1749, so he left c1733. He could have been born no later than 1718.

These papers establish that Avis Whitaker and John Rudd had 8 children (of whom 2 might not have been his), including two daughters whose names had not been given in previous documents: Mary Rudd, who married Alexander Brown, and Elizabeth Rudd, who married Daniel Brown.

Alexander Brown was a tax paying property owner in 1736 according to the taxes collected by John Nash, sheriff of Henrico County, Virginia. This may be the Alexander Brown who married Mary Rudd.

I give and bequeath to my grandson Fedrich Rudd fifty acres of land ajoining David Nunnelly line and if he die without heirs it is to be equally divided between Robert Rudds surviving sons and the other hundred acres is to be equally divided between Aldridge Rudd and Hezekiah Rudd.__Item.
