She appears to be a sister of Hannah Rudd, according to the following: 12 Aug 1737, Amelia Co., Virginia: Anne RUSSELL, William RUSSELL, Hannah RUDD, Elizabeth STORY, and John STORY made oath they had no allowance for persons imported to the colony of Virginia -- Amelia Co. Hannah RUDD was grandmother of Simcock CANNON (who had a son named Russell CANNON). Court Order Book 1, Amelia Co., VA, 1735-1746 by Gibson J. 22 Nov 1740, Amelia Co.: Elizabeth RUSSELL was paid for cleaning the courthouse.

This appears to be the same Edward Storey named in Hannah Rudd's will as her nephew. The Revolutionary War soldier lived on Wintopock Creek, where John and Elizabeth Storey may have lived. The Daughters of the American Revolution list him as Ancestor # A131768. who received Pension # S*W4348. He served under Capt. Francis Goode and Col. Patrick Henry.

According to the web page of Jeri Garner, jerigarner@yahoo.com, at wc.rootsweb.ancestry.com, database "jerigarner," last updated 28 Jan 2007; accessed 03 Sep 2009: The Revolutionary War record of Edward or Edward Robert Storey/ Story/Storie [she uses the Storie spelling] sates "I have no record of my age, but believe I was born the 9th of October, 1756." Later in this record, he said, "I was born in Chesterfield County, Virginia, in the year 1757." He said that after he married Joecy, the lived "on Winterpick Swamp in the neighborhood of Cat-Tail Creek." Jeri Garner also provided more details of his Revolutionary War service and other life events. Four of their children were born before the family moved to Campbell Co., VA, in 1788.

According to Joicy's widow's pension application, cited by Jeri Garner, Joicy and Edward were married by the Rev. William Leigh of the Church of England at Daniel Dixon's near Woods Church..."

Edward's will was signed in Campbell Co., VA, on 17 Feb 1835. The estate was probated 10 Sep 1837, and his son Barlett/Bartlett, was executor. Joicie received his estate during her lifetime, after which it was to be divided equally among their children: Pleasant (deceased), Elizabeth Frazier, Archibald, Barlett, Nancy, and Polly Howell.

Public member stories at Ancestry.com for this Edward Storey state: "The Story family History has been recorded in the book, The History of Pickett County by Tim Huddleston. The branch of the Story family that currently resides in Pickett and Overton Counties are related. The beginning of the Story (Storie Storey) family started with Edward Storey and Joicy Bates Sampson in Chesterfield County, VA. They were married on August 6 1775. He was a Revoutionary War Solider. They moved to Campbell County on August 7 1837, at which time Edward died. Edward, also referred to as Robert, and Joicy had 8 children Edward was born 10/19/1756 in Chesterfield Co. VA.

Edward entered the Rev. War as a volunteer from Chesterfield Co VA. He served a six week enlistment at Williamsburg in Col. Patrick Henry's Regiment. He served a 2nd 6 week enlistment at Portsmouth, in Col. James' Regiment. He stated he received a discharge from both enlistments and returned home after each. He later substituted for Giles Wells, serving 10 months of Wells' 12 month enlistment, and again returned to his home in

Chesterfiled Co. After his marriage to Joicy, they lived "on Winterpock Swamp in the neighborhood of Cat-Tail Creek." _____He was again drafted into Capt. Archibald Walthall's militia regiment, and stated he served "off and on, a number of short tours until Cornwallis was taken at York Town. Col. Creed Taylor and Maj. Wm. Duvall commanded in the last named tours."

On Nov. 14 1832, he filed for a soldier's pension. He claimed nineteen months total service, "all of which discharges I burnt thinking I should never have any use for them," and was granted pension #4348 at the rate of "55 Dollars 44 Cents per annum, to comence on the 4th day of March, 1834." The arrears amounted to \$194..4---Joicy was issued a widow's pension on July 27, 1840. She recieved the same amount as Edward (\$55.44 per year), retroactive to August 8, 1837, the day after Edward's death. The arrears amounted to \$107.57 2 Will: 17 FEB 1835 Campbell Co, VA

Note: Edward signed his will Feb 17th 1835 in Campbell Co. VA--- Willed all to "my wife Jocie Sampson Storer all of my estate both real and personal for and during the term of her natural life" 3 Probate: 10 SEP 1837 Campbell Co, VA Note: Estate probated 10/9/1837 in Campbell Co; son Barlett, was executor. Burial site unknown...probably Campbell Co VA."
