See below: "Note: On 10 Sept. 1760 Thomas Daniel received a grant of two hundred and twenty-seven acres in Brunswick Co., adjoining the lands of Gilliam and Willis. (Bk 33, p 948.) On 27 Aug. 1770 he received a grant of two hundred and fifteen acres in Brunswick Co., adjoining the lands of Briggs and others. (Bk. 39, p. 141.)_ "In 1765 Charlotte Co., Va., was created from part of Lunenburg Co., which in 1746 was created from part of Brunswick Co. On 7 Dec. 1772, "for natural love and affection which he hath and doth bear unto the said Thomas Daniel who hath intermarried with on of the daughters of the said Russell." William Russell conveyed to Thomas Daniel, both of Charlotte Co., two hundred and sixty acres in Charlotte Co., adjoining the lands of James Bowers, Richard Wright, Joseph Russell, and the said William Russell, it begin part of a tract of three hundred and twenty-five acres which William Russell purchased from Benjamin Anderson. (Bk. 3, pp. 161-2.) On 21 Nov 1769 Benjamin Anderson, of Hanover Co., conveyed to William Russell, of Charlotte Co., three hundred and twenty-five acres in

Charlotte Co. "Beginning at the said Russell corner on Buckle Branch, thence along his and Brower's line to Archdeacon corner." (Bk. 2, pp. 252-4.)

"Thomas Daniel did not remain permanently in Charlotte Co. He returned to Brunswick Co. and settled near his father and there spent the remainder of his life. When he did so is not known, but his name appears on the Brunswick Co. taxpayer lists 1798-1803, with "dec'd" written by it in 1903. It was not found on later tax lists. In 1804 the tax list includes his widow Mary Daniel, Joseph Daniel, Hezekiah Daniel, and James Daniel. This indicates that his death was 1803.

"William Hammond, George Trotter, and Joshua Pritchett made an inventory and appraisal of the estate of Thomas Daniel. It was submitted for record in Brunswick Co. 28 Oct. 1805 by Joseph Maclin, Administrator and Justice of the Peace. It includes furniture, farm equipment, livestock, slaves, and "a bell in the hands of Joseph Daniel." (Bk. 7, p. 174.)"

WIFE - Mary "Molly" Russell

Named as a child in her father's probate documents.

19 Dec 1788 Charlotte Co., VA. Thomas Spencer, Jr., and Quin Morton made further division of the estate of William Russell, deceased: one third to the relict Anne Russell; other two thirds remainder of the estate to the deceased's eight children: Edward, Joseph, JAMES, Mary, John, Thomas, Nancy, Peggy, and to John Russell, the representative of the deceased's son William Russell, Jr. Recorded 07 Apr 1789. Charlotte Co. Wills, 1:412a-413a, abstracted in Hart & Kolbe, Southside Virginian, 6(2):93 (April 1988).
