He was a minor when his father died in 1788.

- 03 Apr 1788 Charlotte Co., VA. The will of William Russell dated 03 Apr 1788, named wife Anne. Directed that land be divided between [sons] Thomas and John Russell. Devised negro Mitty to Edward Russell. Mentioned [children] Nancy, Joseph, Peggy Russell. Will presented to the Court by Anne Russell, relict of William Russell and by William Russell, son of Edward Russell and recorded 01 Sep 1788. Charlotte County Wills, 1:409-409a, abstracted in Hart & Kolbe, Southside Virginian, 6(2):92 (April 1988).
- 01 Dec 1788 Charlotte Co., VA. Josiah LeGrand was appointed guardian of Nancy, Thomas, John, and Peggy Russell, orphans of William Russell, deceased. Securities: Jacob Morton, Anne Russell. Thomas Spencer Jr., Quin Morton, Thomas Read appointed to settle William Russell's account as guardian of John Russell, orphan of William Russell, Jr., and they are directed to report the same to the next Court. Charlotte Co. Court Orders, 7:221-223, abstracted in Magazine of Virginia Genealogy 25(4):24, 1987.
- 19 Dec 1788 Charlotte Co., VA. Thomas Spencer, Jr., and Quin Morton made further division of the estate of William Russell, deceased: one third to the relict Anne Russell; other two thirds remainder of the estate to the deceased's eight children: Edward, Joseph, James, Mary, John, Thomas, Nancy, Peggy, and to John Russell, the representative of the deceased's son William Russell, Jr. Recorded 07 Apr 1789.
